




Working with the Expert Group on Migration Statistics

EGRISS is actively working to enhance cooperation and build on synergies with the <u>UN</u>

<u>Expert Group on Migration Statistics (EGMS)</u> to improve the coherency of efforts. That's why we joined the <u>Technical Workshop on International Migration and Temporary Mobility Statistics</u>, organised by the EGMS and hosted by <u>Statistics Poland</u>, in Warsaw on 16th to 19th July. Our contribution focused on how to align the conceptual, technical, and operational aspects of statistics on migrants, refugees, IDPs, and stateless populations.

Enhancing the ICL Guidelines on International Labour Migration Statistics

ILO has launched a revision of the <u>International Conference of Labour Statisticians (ICL)</u> <u>Guidelines concerning Statistics of International Labour Migration</u> to ensure they better align with the revised/new recommendations on international migration, refugees and statelessness. EGRISS Secretariat and several members have joined the Technical Working Group to ensure the IRRS and IROSS are fully and accurately reflected, and provide further guidance based on the <u>Compiler's Manual</u>.

Improving interoperability between population, displacement, and refugee data



EGRISS EXPERT GROUP ON REPUGEE,

In August, <u>Statistics South Africa</u> represented EGRISS at the Technical Workshop Learning and Adapting lessons on Baseline Population, displacement and refugee data interoperability in Johannesburg, organized by <u>UNFPA</u>. During the workshop, the International Recommendations on Refugee, IDP and Statelessness Statistics were shared, alongside EGRISS's ongoing efforts to promote and support their implementation.

Implementation examples

Rwanda: Including refugees and statelessness in the population census

Rwanda hosts significant numbers of refugees, with many of them residing in the country for decades. The inclusion of refugees and statelessness in their 5th Population and Housing Census (RPHC-5) presents a concrete example of implementation of IRRS, whose results will inform national and sub-national policies related to the socio-economic inclusion and wellbeing of refugees and will inform further analytical work on statelessness.

Honduras: Informing durable solutions for IDPs with national statistics

Statistical inclusion on forced displacement has progressed in the country with the incorporation in the multi-round Permanent Multipurpose Household Survey 2023 (EPHPM) of questions to identify IDPs. IRIS was used to inform the process, guiding the overall statistical framework and with identification questions adapted to the national context. Lessons learnt concern the application of these efforts in situations of generalized violence.

The Expert Group on Refugee, Internally Displaced Persons, and Statelessness Statistics (EGRISS) is a multi-stakeholder group mandated by the United Nations Statistical Commission to develop and support the implementation of international statistical recommendations on refugee, IDP, and statelessness statistics. EGRISS was established in 2016 and currently includes 59 countries and 37 institutional partners. The group aims to improve the quality and availability of official statistics on these populations by advocating for and supporting their inclusion in national statistical systems, to help ensure they are not left behind as countries work to achieve their development goals.
