













# Workshop on International Recommendations on Statistics of Refugees, Internally Displaced Persons and Stateless Persons

Egypt-Cairo, 26-28 November 2024

### **Conclusion and recommendations**

















Within the framework of efforts to collect, analyse and disseminate data on statistics of refugees, internally displaced persons and stateless persons, the United Nations Economic and Social Commission for Western Asia (ESCWA), in cooperation with the Arab Institute for Training and Research in Statistics (AITRS) and the Expert Group on Statistics of Refugees, Displaced Persons and Statelessness (EGRISS), organized a workshop on the international statistical recommendations for refugees, internally displaced persons and stateless persons. The workshop was co-organized with the UN Agency for Refugees (UNHCR), the Joint Internal Displacement Profiling Service (JIPS), the UN Relief and Works Agency for Palestine Refugees in the Near East (UNRWA) and the United Nations Population Fund (UNFPA). It took place during the period from 26 – 28 November 2024, generously hosted by the League of Arab States in Cairo, Arab Republic of Egypt.

The workshop aimed to familiarize participants with the International Recommendations related to statistics of refugees, internally displaced persons and stateless persons, and to strengthen the capacity of Member States to collect data on these populations in accordance with the international statistical standards developed by the Expert Group on Refugees, Internally Displaced Persons and Statelessness Statistics (EGRISS).

In its sessions, the workshop discussed issues related to the challenges faced by countries in collecting, analyzing and disseminating refugee data, national and regional coordination issues, and the most important features of the International Recommendations related to statistics of refugees and internally displaced persons. The workshop provided an introduction to the EGRISS, offering an overview of the group's mandate, membership, and key resources. Central to discussions were the International Recommendations (IRRS, IRIS and IROSS). During presentations, the frameworks were presented as well as the populations they focused on, helping participants gain a deeper understanding of the three statistical frameworks and their foundations in legal and policy definitions. The sessions also encouraged reflection on how countries in the region can advance this work, emphasizing the importance of integrating these efforts into existing mechanisms and ensuring continued progress. The workshop was attended by representatives from national statistical agencies and relevant ministries from fourteen countries: Djibouti, Egypt, Iraq, Jordan, Lebanon, Libya, Mauritania, Morocco, Palestine, Somalia, Sudan, Syria, Tunisia and Yemen, as well as regional and international experts from the above organizers.

The workshop concluded with a set of recommendations and ways forward:

#### **Recommendations to Arab countries**

- 1. Strengthen national statistical offices and enhance capacity where needed to enable better coordination between relevant stakeholders, including for example refugee and IDP committees, national statistical offices, migration authorities, ministry of planning, ministry of interior and other relevant institutions to determine data needs and streamline the collection and use of data on refugees, IDPs and stateless persons.
- 2. Assess the availability and quality of existing data on refugees, IDPs and stateless persons to identify opportunities for improvement, based on the statistical frameworks included in the recommendations emanating from the EGRISS.
- 3. Identify upcoming opportunities to include/identify refugees, IDPs and stateless persons in national census, administrative registries and relevant household surveys. Develop concrete steps to include these populations in data collection and analysis, for example through the use of booster samples for displaced persons, appropriate identification questions and analysis plans.
- 4. Integrate innovative and big data sources with traditional data from census, household survey and administrative data for a comprehensive view of the situation of refugees, IDPs and stateless persons.
- 5. Ensure that refugee, IDP and statelessness statistics are incorporated into national statistical development strategies.
- 6. Promote the adoption of the International Recommendations on Refugee, IDP and Statelessness Statistics (IRRS, IRIS and IROSS) in national statistical plans and activities through advocacy, training and other capacity strengthening efforts.















7. Document and share experiences and best practices in the application of the IRRS, IRIS and IROSS, and urge member states and other organizations to consider joining the membership of the Expert Group on Refugee, IDP and Statelessness Statistics (EGRISS).<sup>1</sup>

#### Recommendations to international and regional partners

- Present the work of the regional sub-group and outcomes of the current workshop to the regional Technical Advisory Group in Demography and Social Statistics in 2025.
- Integrate topics related to displacement and statelessness statistics into the workplans of existing regional coordination mechanism on CRVS and censuses.
- Translate EGRISS resources like the IROSS, E-learning, 'Recommendations Ata-Glance' documents and Compiler's Manuals on Forced Displacement Statistics into Arabic for wider accessibility.
- 4. Mobilize resources for coordination and capacity strengthening and resource mobilization.
- 5. Given the specificities of displacement and statelessness dynamics in the region such as multiple displacements across different statistical population categories and Palestine refugees in the region, develop regional guidance for countries to apply the EGRISS framework and other statistical recommendations like the Principles and Recommendation for Population and Housing Censuses, and to learn from similar processes in other regions.
- 6. Strengthen collaboration in the design and implementation of surveys and special studies on refugees, IDPs and stateless persons to ensure full coverage of pertinent topics, including reproductive health and age disaggregation.
